SEE REVERSE SIDE FOR PERMIT REQUIREMENTS

REQUIREMENTS

1. No work under this application is to be started until application is approved and the permit issued.
2. Where work on traveled roadway is necessary, traffic must be protected, and the proper traffic control devices must be placed in accordance with the standards of the Minnesota Highway Department.
3. The applicant shall provide and install the necessary culvert pipe and aprons for the access to be constructed or reconstructed. A culvert pipe with a 15" diameter minimum is required unless stated in the special provisions.
4. If used culvert pipe is allowed, the culvert must be inspected by the City's representative prior to installation.
5. The applicant shall be responsible for the furnishing and placement of all soils needed in the construction or reconstruction of the access embankment to the permit requirements.
6. Access side slopes shall be constructed per the Zoning Ordinance or as per the special provisions and shall be hand finished and seeded.
7. The access shall be gravel surfaced or surfaced as per the provisions of this permit.
8. No foreign material such as dirt, gravel, or bituminous material shall be left or deposited on the road during the construction of the access.
9. Roadside must be cleaned up after work is completed.
10. No changes or alterations in accesses may be made without written permission from the City.
11. After access construction is completed, the permittee shall notify the City that the work has been completed and is ready for final inspection and approval.
12. In the event that the construction has not been started within one year of the permit approval date, this permit becomes null and void.
13. No fences, rocks, trees, shrubs or other obstructions shall be placed by the driveway within the road right-of-way.
