Ordinance No. 2009-16

AN ORDINANCE AMENDING THE GRANT CODE OF ORDINANCES CHAPTER 32, ZONING, SECTION 32-246 REGARDING MINIMUM LOT REQUIREMENTS

On December 1, 2009, the City of Grant adopted an ordinance amending the City's Code of Ordinances regulating minimum lot requirements to include a definition of the term "arterials" and revise the minimum area, maximum height and other dimensional requirements for lots within the City of Grant.
